Prohibition of Ragging in Educational Institutions act 26 of 1997

Salient Features

- ❖ Ragging within or out side any educational institution is prohibited.
- ❖ Ragging means doing an act which causes or is likely to cause insult or Annoyance or fear or Apprehension or Threat or Intimidation or outrage of modesty or injury to a student

Teasing,
Embarrassing and
Humiliation

Imprisonment up to
6 months + Fine up to 1,000/-

Assaulting or Using
criminal force or criminal
intimidation

Imprisonment up to
1 year + Fine up to 2,000/-

Wrongfully restraining or
confining or causing hurt

Imprisonment up to
2 years + Fine up to 5,000/-

Causing grievous hurt,
kidnapping or rape or
committing unnatural
offence

Imprisonment up to
5 years+ Fine up to 10,000/-

Causing death or abetting
suicide

Imprisonment up to
10 years + Fine up to 20,000/-
